DESCRIPTION

- **254 LANKO NET ROUGE** is an algacidal and fungicidal liquid cleaner for the prevention and cure of red algae and lichen on building materials.
- **254 LANKO NET ROUGE** treats, destroys and prevents the formation of red algae.

USES

- On buildings: gables, façades, roofs, terraces, balconies, outdoor stairs...
- Outdoor features: paving stones, pathways, garden walls, ornamental basins, statues, balusters, ponds (except fishponds)...
- Leisure facilities and amenities: e.g. tennis courts, caravans...
- Compatible with a range of ParexLanko finishing materials after rinsing.

INSTRUCTIONS

■ CONDITIONS OF USE

- Apply in dry weather.
- Protect from rain.
- Do not apply to a frozen or thawing substrate.
- After application, allow the product to take effect – do not rinse immediately.
- Protect all plant matter bordering areas in which the product is applied.
- Do not apply to any materials that may come into direct contact with foodstuffs.
- A preliminary sample test should be performed, especially for lichen.

■ SUBSTRATE PREPARATION

- For best results, remove a maximum amount of organic pollution and plant matter before application, e.g. by brushing or with high-pressure water.

■ PRODUCT PREPARATION

- Shake the container well before use.

■ APPLICATION

Curative action - application to a substrate covered in red algae

- Remove a maximum amount of red algae by scraping or brushing.
- Apply **254 LANKO NET ROUGE** directly to the surface requiring treatment by means of a **brush, roller, squeegee broom or a low-pressure spray**. Ensure that the surface is completely impregnated.
- For best results, a roller or squeegee broom should be preferred.
- **Leave to take effect for at least 12 hours in dry weather.**
- The red algae will gradually dry and become black.
- Remove these black deposits by brushing or with a high-pressure water cleaner.
- On heavily affected areas, repeat the treatment operation if necessary.

Preventive action - application to a clean and unaffected substrate

- Treat substrates **in spring or autumn** so as to prevent proliferation of algae or lichen that may lead to permanent damage, e.g. severe soiling, unsatisfactory rainfall run-off, etc.
- Apply **254 LANKO NET ROUGE** directly to the surface requiring treatment by means of a **brush, roller, squeegee broom or a low-pressure spray**. Ensure that the surface is completely impregnated.
- Do not rinse.
- Surfaces treated with **254 LANKO NET ROUGE** can be preserved even longer by using one of our special protection products:
 - **238 LANKO RESIST HYDRO**
 - **239 LANKO RESIST SOL MAT**
 - **240 LANKO RESIST EFFET MOUILLÉ**

- ▶ **18 months**
from date of manufacture if stored in unopened original packing in dry, frost-free conditions, away from high temperatures and heat sources

If spraying:

- Use a scrupulously clean low pressure spray (less than 3 bars, e.g. garden spray) so as to prevent fogging.
- Use a protective visor and wear suitable protective clothing when spraying.
- Ideal application conditions are generally before 8 am and after 8 pm.
- Do not use a spray in windy conditions: use a brush, roller or squeegee broom if this is the case.
